Summing up all the contents of the earlier notifications / letter vide nos No ASSEB/DIV II/EXB/11/47/18/19-20/464 dated 05/07/2025 ASSEB/DIV II/EXB/11/47/18/19-20/488 dated 20/11/2025 & ASSEB/DIV-II/EXB/MISC/2025/ dated 22/12/2025 regarding holding of District Level Internal Examinations in HS 1<sup>st</sup> Year & HS 2<sup>nd</sup> Year, the DLIEC of each District is advised to follow the following tentative schedule for the session 2026-27

H.S. 1 <sup>st</sup> Year Examinations (Class XI)

November, 2026	Half Yearly	50

March, 2027	Annual Examination before 31 <sup>st</sup> March, 2027	100

H.S. 2 <sup>nd</sup> Year Examinations (Class XII)		
Month & Year	Name of the Examination	Marks
June, 2026	Unit Test 1	25
September, 2026	Half Yearly	50
October, 2026	Unit Test 2	25
December, 2026	Revisionary Test	Only Theory Examination will be held. Total marks of each subject will be as per syllabus of HS final examination (Theory)
February/ March, 2027	H S Final Examination, 2027	100

It is also for all concerned that-

- 1) All Unit Test, Half Yearly, Revisionary Test & Annual Examinations of HS 1<sup>st</sup> Year (Class XI) & HS 2<sup>nd</sup> Year (Class XII) as the case may be, are to be conducted by all the Higher Secondary and Senior Secondary Schools under the jurisdiction of ASSEB, Div-II mandatorily
- 2) The Colleges & Universities are exempted from holding Unit Test 1 and Unit Test 2 considering their engagement with Semester system in Higher Classes.
- 3) However, Half Yearly (HS 1<sup>st</sup> & 2<sup>nd</sup> Year), Revisionary Test (HS 2<sup>nd</sup> Year) & Annual Examinations (HS 1<sup>st</sup> Year) are also mandatory for Colleges & Universities.
- 4) DLIEC may conduct Half Yearly (HS 1<sup>st</sup> & 2<sup>nd</sup> Year) Examination & Revisionary Test (HS 2<sup>nd</sup> Year) through two different schedules one for the Higher Secondary and Senior Secondary Schools and other for Colleges and Universities
- 5) DLIEC may decide to allow all the Institutions under their jurisdiction to conduct the Unit Test 1 & Unit Test 2 by the institutions themselves with the Question Papers set by the institution at their own level.
- 6) But, in case of Half Yearly (HS 1<sup>st</sup> & 2<sup>nd</sup> Year), Annual Examination (HS 1<sup>st</sup> year) & Revisionary Test (HS 2<sup>nd</sup> Year) Question Papers must be prepared by the DLIEC only
